6. Reports

- a. President's Report: George T. Fields, GSS President
 - Organizational Updates
 - Stipends
 - In our conversations with university administrators, the issue of stipends is as complex a topic as imagined. Though the situation has been exacerbated with recent spikes in inflation and costs of living, the response from the university (though filled with sympathy and understanding) has remained the same: that the situation is too complex to resolve through university-wide solutions. Instead, stipends and graduate compensation overall have been left to the academic colleges and departments, which are given the discretion to determine

- what we will be paid and how vast the inequality between graduate stipends are based on the terms of our employment contracts. The university has set minimums for what graduate assistants can be paid, and those minimums are set based on the terms of our contract: our duties and the duration of our contract.
- Looking forward, we need to explore creative ways to get academic colleges and departments to consider raising our stipends more than they have to match the increased costs of being graduate students on Rocky Top.

Healthcare

- Many of you submitted questions prior to representatives from the Student Health Center visiting the Senate during the November Session.
- Following that Session, we communicated with them and received formulated responses addressing the submitted questions. Those were shared in my email earlier this week.
- If you have concerns, start there, and of course communicate with me any lingering questions or concerns you have, as Leighton and I are meeting with those administrators in the coming weeks to discuss making healthcare through the Student Health Center more accessible for graduate students.

OIT and Software

- At the September Session, Senators submitted questions about the process by which students can request that the university acquire software licenses to assist with research.
- Their response was also shared this week, and I want to highlight that Dr. Reeves, Chief Information Officer for the university, stated that the two graduate seats on the UT Tech Fee Advisory Board are among the best ways for graduate students to influence these types of processes.
- To that end, those positions have been on the list of external committees we have been promoting since September.
- If you are interested in learning more about how the university processes requests for technology, including software, please consider volunteering to fill the positions we have on that board. I'll touch on more of that later during my update of vacant committee positions.

Parking

- As you all may have seen on our Slack channel earlier this afternoon, parking scenarios on campus are worsening as our sports teams excel and campus becomes overall busier as a major part of the Knoxville community.
- One of the main issues with parking we have identified is the lack of communication with university personnel about best practices regarding parking.
- In an attempt to remedy this, we have maintained regular communication and collaboration with Parking and Transit.
- In that light, we will forward any communications we receive regarding parking interruptions on campus, evolving parking situations, and efforts to relieve the pressure on parking demand on campus.
- We are also working with senior administrators in a plan to evaluate and identify underutilized lots on campus in a larger effort to examine the overall parking situation on campus within the contexts of accommodating faculty, students, and staff.

- Some of you also questioned printing on campus, including how the university might be able to support students whose departments either don't provide or limit printing associated with our duties.
- Though we are waiting on an official response, information we have gathered points to the expectation that students can rely on their department to provide what's needed.
- Concerns about that expectation need to be shared so we can look into specific situations.

• New News

Elections

- Though it is still almost two months away, as an organization we need to begin the conversation about the election of the next President and Vice President of the Senate. If you or someone you know is interested in running for one of these elections, please feel welcome to reach out to Leighton, Nick, or myself for more information and insights into those positions.
- More information about the election will be shared in the coming weeks.
- On the topic of elections, it is time for us to take stock as an organization and begin thinking about how Senators in your academic unit are selected.
 - We will be sharing a survey to all of you in the coming weeks to gather information on how your academic units handle the selection of Senators. It is important to remember as we move forward that Senators are representatives of graduate students, and thus graduate students should play a role in selecting their representation on the Senate.
 - Keep an eye out for that survey and communicate with us if you have any questions.

Resolutions

- The GSS is actively pursuing a couple of resolutions aimed at improving the graduate student experience. We are also exploring, based on the interests and concerns some Senators have expressed:
 - resolutions addressing the space issue on campus,
 - addressing stipend inequality on campus (touching back to my points earlier),
 - and addressing construction plans on campus.
- The Legislative Steering Committee has also stated that they will be publishing a resolution guide for Senators, which provides guidelines for how Senate resolutions should be constructed and presented.
 - Hannah Thompson, the Chair of Legislative Steering, has expressed that the committee is poised to assist Senators with topics of interest and exploring whether interests are fitted for a resolution.
 - Use the committee as a resource if you wish to pursue a resolution.

Chancellor's Email Regarding Business Building Construction

- If you haven't seen it, the Chancellor released an announcement to the campus specifying the updated plan for the construction of the new business building and the related demolition of Greve, Henson, and Dunford Halls.
- Concerns we have heard from Senators at previous Sessions include those surrounding where academic and administrative units in those halls will be moved, and how their relocation will impact their engagement with the larger campus community.
- Based on her communication, it seems that the university has arranged for some of those units to move into Stokely Management Tower.

- Remaining questions I have include exactly which units will move into the Tower, and how moving into the Tower affects issues of access to office space for the faculty, staff, and students in those units.
- We are actively seeking more information from the administration and will report back.

o GSS Office Move

- A piece of good news for the organization we are moving the GSS office to a space that is more accessible to students and better accommodates the needs of the organization.
- We will be moving to the CSE suite of the Student Union, in the area behind Steak and Shake.
- As we finalize this move, please feel free to stop by and see the new space. Being in this office will enable us to better network with organizations and administrators on campus, and will facilitate collaboration with the SGA, which is also located in that CSE suite.

Question from Senator 99: Any updates from the Chancellor's Town Hall Meeting? **Answer:** Office of Ombud Services – Duren Thompson –

Speaking about what happened in the Town Hall meeting on the Campus Master Plan Three things were that their immediate priorities were to address space issues in Chemistry, improvement issues in Arts & Sciences/Humanities, and Graduate Student Housing (there is currently no graduate student housing, but Chancellor stated that that needs to change). Also there has been a call from the student population to make campus more walkable and bikeable which would require construction of roads and bike paths on campus which will also impact parking.

Question from Senator ?: Regarding this stipend issue? I know. Spent a lot of time and thanks for that. But I noticed the website you shared it. It was 2021 which was way before this inflation.

Answer from George: I spent some time looking through the resources that they had published, and there is nothing for 2022, which is exactly what we're going to be seeking -- and well, really, it'll be 2,023 right? My goal is to use the very real problems that we have with inflation and cost of living housing demand, which, as you touched on, I'll touch on in a minute, because I'm going to talk briefly about the housing report.

Question from Senator 77: Is there a way to make it so there is no minimum/maximum and that all grad students receive an equal stipend?

Answer from George: Yeah, that's a valuable piece of input. I know that the University, for staff positions, they do provide in their market ranges which are published online. They do provide a range, and that seems to be the model. But we can explore, making sure that the minimum and maximums aren't so far apart, and to try to meet that while also understanding that their response is going to be that it has to be a range, but we can work on that, and I'll take note of that and see what we can do.

Question from Senator 93: question about email regarding using non-utk email **Answer from George**: So a couple of pieces of information for you: while waiting for people to step forward to fill the Tech Fee Advisory Board position, I did attend the first one, and at that meeting they specifically talked about the fact that they are re-evaluating how the university handles storage, and how they manage it. OIT discussed back in September about Alumni losing the utk email due to storage space. I encourage you to think about joining the Technology Advisory Fee Board to speak directly with them and so we can respond to their direct feedback from our concerns.

c. Discussion: Graduate Student Housing Task Force Report

GSS President, George T. Fields will address the recommendations included in the Report and will discuss the next steps regarding housing.

• Operational recommendations:

- Creating a housing coach program for graduate students; one option would be to offer stipend to current grad students who could mentor new/incoming students as a housing resource
- Considering the enrollment of undergraduates and how that creates a strain on the housing market in Knoxville.
- Providing direct financial support to graduate students to offset the rising cost of living for graduate students.
- Identifying a single point of contact for grad students to access that subsidy
- Signing a master lease agreement with at least 1 or more than 1 apartment complex within 15 minutes of campus
- Consider a staffing structure for housing agreements etc.
- Establish communication resources from the university for housing
- 2024-29: prioritize affordable housing while maintaining these affordable options and keep them once on-campus housing is made available.
- Arranging for free or discounted transportation
- Increasing grad student assistantship stipends
- Making sure we have master lease agreements with older apartment complex structures near campus
- Standardize process for sharing information
- Long-term 2030 -beyond: make sure graduate student housing is a priority for the UT Southside expansion.

- Comment from Senator 44: The educational psychology and Counseling Department has a counselor training clinic, and we offer free counseling services. So just a general plug for that. It's opt in overflow for the counseling center on campus. Obviously, there the interns there are in training in Masters program or doctoral interns. So that's a caveat. But the one thing I wanted to specifically highlight is. We've partnered with the Title IX office for a sexual assault survivor support group that is open for undergrads or graduate students. So I know that's very niche, but needed on campus.
- Senator 75: Multiple places of employment at the university through multiple departments is there a way to be paid (for grad students to be paid) at the same time for those positions?
- Answer from George: This is very specific, so email me more info and we will look into it.
- Question from Senator on Zoom: will the Counselling support group be available online? Answer from Senator 44: not currently
- Question from senator #9: I had a medical emergency last semester that involved me going to the emergency room with the salary of a grad student and rising prices of everything. This puts an even greater financial strain on me. I applied for the emergency fund because medical emergencies are included in the reasons for applying, but was rejected because I have access to additional loans. Is there anything that we can do about this?

Answer from George: I think what the references is the fact that if there are financial aid considerations pertaining to student loans that limits the University's ability to give out fellowships, which is usually how that types of that type of support is administered to that end. This is a growing concern, as the cost of living is going up. The need for loans is going up. It's really putting a lot of students across the University in a tight spot in terms of receiving support for the university. That then applies to the loans instead of to the student directly, and particularly. I think that students are probably in the mindset that they would prefer to have to support now than apply to their loans that they're going to pay off over the course of a few years or hopefully, not decades right so to that point we can look at trying to establish through the University system another way for people to receive financial support that doesn't take financial aid into consideration, and we can see what we can do there. That is a big step because you're trying to affect policy at the system level, but there's nothing too big that we can't handle, or at least get

good clarification on.


